AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS ECHO GREENS TOWNHOUSES SECTIONS I AND II

THIS AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS, ECHO GREENS TOWNHOUSES SECTIONS I AND II, made this _____ day of October 2022, by ECHO GREENS HOMEOWNERS ASSOCIATION ("Association"), a North Carolina non-profit corporation, party of the first part, and the Lot Owners of Townhouses in Sections I and II of ECHO GREENS TOWNHOUSES ("Lot Owners"), party of the second part.

WITNESSETH:

WHEREAS, a Declaration of Covenants, Conditions and Restrictions of Echo Greens Townhouses, Sections I and II, was executed on April 18, 1985, and recorded on April 24, 1985, in Book 1285, at Page 966 of the New Hanover County Registry, which established certain restrictions, covenants and conditions with respect to the use, enjoyment and ownership of that property known as "Echo Greens, Inc., Section I", as shown on that Map recorded in Map Book 25, Page 16, of the New Hanover County Registry; and

WHEREAS, said Declaration was amended by that Supplemental Declaration of Covenants, Conditions and Restrictions dated June 7, 1985, filed June 9, 1985, and recorded in Book 1290, Page 0930 of the New Hanover County Registry, to establish certain restrictions, covenants and conditions with respect to the use, enjoyment and ownership of that property known as "Echo Greens, Inc., Section II" as shown on that plat recorded in Map Book 25, Page 39, of the New Hanover County Registry; and

WHEREAS, it is the desire of the Association and the Lot Owners, that Article II, entitled "ASSOCIATION," Section 5, Paragraph c.5 of the Declaration, be amended as set forth below.

NOW, THEREFORE, in consideration of the mutual covenants set forth in the Declaration, as amended, creating Echo Greens Homeowners Association, said Declaration of Echo Greens Homeowners Association is hereby AMENDED by deleting Article II, entitled "ASSOCIATION," Section 5, entitled "POWERS, PRIVILEGES, RIGHTS, AND OBLIGATIONS," Paragraph c., entitled "Insurance," subparagraph 5 of the Declaration and substituting the following:

(5) All insurance policy premiums on the Property for the benefit of the Association purchased by the Executive Board or its designee shall be a common expense.

The Association shall levy against the Owners an additional annual assessment, or include within the normal annual assessment, an amount sufficient to pay the annual cost of insurance premiums. The individual Owner(s), not the Association, shall be responsible for payment of any deductible of any claim pursuant to any insuring agreement for property damage or loss of use regarding any covered or non-covered loss applicable to any individual Owner's Townhouse or Lot which originates inside the Townhouse(s) of any Owner(s). Any loss proximately caused by any event which originates inside any Townhouse(s) of any Owner(s) shall be paid by the Owner(s) affected by the loss. Specifically, no plumbing leaks (defined as "all" non-weather related leaks) of any kind are covered by any Master Association insuring agent. The Association shall pay the deductible for any covered loss originating from Acts of God, weather, and other conditions or disasters created by Nature and/or those events which originate outside the Owner(s)' Townhouse.

Except as to the aforementioned Amendment to said Declaration, as amended, all other terms and conditions of the Declaration, as amended, remain in full force and effect.
