AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WESCOTT ESTATES

UNOFFICIAL

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WESCOTT ESTATES, made and entered into this 7th day of November, 2013, by Wescott of Southport, LLC, a North Carolina limited liability company, to and with and on behalf of all persons now and hereafter owning or acquiring any of those lots as shown on those maps of Wescott Farms (now Wescott Estates) recorded in Map Cabinet 35 at pages 408-409 and revised in Map Cabinet 37, Pages 19-20, of the Brunswick County Registry.

WITNESSETH

WHEREAS, the original Declarant, Wescott, LLC, caused to be recorded the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WESCOTT FARMS in Book 2453 at Page 1293, in the office of the Brunswick County Registry; and

WHEREAS, Wescott, LLC filed an AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WESCOTT FARMS, in Book 2748, Page 554, Brunswick County Registry; which Amendment changed the name of the development to WESCOTT ESTATES; and

WHEREAS, the original Declaration, under Article XI, Section 4, provides that, "For so long as Declarant owns any lots or units within the Properties, this Declaration may be amended by the Declarant, without the consent of joinder of any other Owner or the Association. Any such



amendment shall be effective upon recording of same in the applicable public registry for Brunswick County, North Carolina; and

WHEREAS, WESCOTT OF SOUTHPORT, LLC acquired all of Declarant's interest in Wescott Estates, consisting of thirty one (31) lots, by deed recorded in Book 3323, Page 930, Brunswick County Registry; and

WHEREAS, WESCOTT OF SOUTHPORT, LLC also received an Assignment of Declarant Rights with regard to Wescott Estates; and continues to own lots within Wescott Estates; and

WHEREAS, the Declarant desires to amend the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS; and

NOW THEREFORE, pursuant to the fights reserved by and to Declarant in the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS, Declarant amends said Declaration as follows:

I. Article VII, Section 11 of said Declaration is hereby amended by replacing the second paragraph of Article VII, Section 11 to read as follows:

II. Article VII, Section 14 shall be stricken in its entirety and replaced with the following: "Section 14. Antennae and Roof Structures. Radio or other electrical towers, aerials,



antennae or other devices for the reception or transmission of radio broadcasts or other means of communications may be installed on a lot; provided, the owner first gets approval from the Architectural Review Committee ("ARC"). The ARC shall have the absolute authority to approve or reject the installation of and location of any such device. Such devices shall be located on the lot such that they are obstructed from view from the street or adjoining lots, as much as possible. If they cannot be located on a particular lot such that they are somewhat obstructed from view, the ARC shall have the authority to reject the request. This restriction shall not apply to those antennae specifically covered by C.F.R. Part 1, Subpart S, Section 1.4000 (or any successor provision) promulgated under the Telecommunications Act of 1996, as amended from time to time. The Association shall be empowered to adopt rules governing the types of antennae that are permissible hereunder and establishing reasonable non-discriminatory restrictions relating to safety, location and maintenance of antennae.

EXCEPT as herein amended, the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS, as previously amended, shall remain in full force and effect.
