AMENDMENT TO THE **DECLARATION OF** COVENANTS, CONDITIONS, AND RESTRICTIONS OF HEWLETT'S RUN

COUNTY OF NEW HANOVER

WHEREAS, The DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS OF HEWLETT'S RUN, a.k.a. Hewlett's Run HOA, Inc. was recorded on October 9th 1997, in Book 1976 at page 0830, in the office of the Register of Deeds, New Hanover County, State of North Carolina; and

WHEREAS, such Declaration under ARTICLE XIII, Section 5, provides that, "The covenants and restriction of this Declaration may be amended by an instrument duly recorded in the Office of the Register of Deeds of New Hanover County signed by not less than two-thirds (2/3's) of the Owners of the Lots within the Properties; provided that no amendment shall alter any obligation to pay ad valorem taxes or assessments for public improvements, as herein provided, or affect any lien for the payment thereof established herein.."; and

WHEREAS, such Declaration under ARTICLE VI, Section 5, subsection c provides that, "All insurance policy premiums on the property for the benefit of the Association purchased by the Board of Directors or its designee and any deductible payable by the Association upon loss shall be a common expense and the Association shall levy against the Owners equally as an additional annual assessment (herein called "insurance Assessment), a charge which shall be in addition to the amounts provided for under Sections 3 above." and

WHEREAS, the members and Board of Directors of Hewlett's Run desires to modify ARTICLE VI, Section 5, subsection c; and

WHEREAS, to accomplish this purpose ARTICLE VI, Section 5, subsection c, shall read, "All insurance policy premiums on the property for the benefit of the Association purchased by the Board of Directors or its designee and any deductible payable by the Association upon loss shall be a common expense in the event of an Act of God and the Association shall levy against the Owners equally as an additional annual assessment (herein called "insurance Assessment), a charge which shall be in addition to the amounts provided for under Sections 3 above. Upon any loss that is not an Act of God the deductible shall be assessed to the unit or units suffering loss and prorated to the proportion of the total loss suffered by all units which suffer loss." and

WHEREAS, the signatures of two-thirds (2/3rd's) of each class of the members of the Association have been obtained in accordance with ARTICLE XIII, Section 5, as attested to by the Association President and Secretary;

NOW, THEREFORE, IT IS RESOLVED, that ARTICLE VI, Section 5, subsection c, is hereby amended to read as follows: "All insurance policy premiums on the property for the benefit of the Association purchased by the Board of Directors or its designee and any deductible payable by the Association upon loss shall be a common expense in the event of an Act of God and the Association shall levy against the Owners equally as an additional annual assessment (herein called "insurance Assessment), a charge which shall be in addition to the amounts provided for under Sections 3 above. Upon any loss that is not an Act of God the deductible shall be assessed to the unit or units suffering loss and prorated to the proportion of the total loss suffered by all units which suffer loss."


