AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF HEWLETT'S RUN

COUNTY OF NEW HANOVER

WHEREAS, The DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS OF HEWLETT'S RUN, a.k.a. Hewlett's Run HOA, Inc. was recorded on October 9th 1997, in Book 1976 at page 0830, in the office of the Register of Deeds, New Hanover County, State of North Carolina; and

WHEREAS, such Declaration under ARTICLE XIII, Section 5, provides that, 'The covenants and restriction of this Declaration may be amended by an instrument duly recorded in the Office of the Register of Deeds of New Hanover County signed by not less than two-thirds (2/3's) of the Owners of the Lots within the Properties; provided that no amendment shall alter any obligation to pay ad valorem taxes or assessments for public improvements, as herein provided, or affect any lien for the payment thereof established herein.."; and

WHEREAS, such Declaration under ARTICLE VI, Section 12 provides that, "At the time title is conveyed to an owner, each owner shall contribute to the association as a working capital reserve the amount of Two Hundred Dollars (\$200.00). Such Funs shall be used solely for initial operating and capital expenses of the Association, such as pre-paid insurance, supplies, and the Common Area and facilities, furnishings, and equipment, etc. Amounts paid into the working capital fund are not to be considered as advance payment of regular assessments. Any working capital funds remaining at the end of the first full operating year shall be transferred to and become part of the general funds of the Association, in the discretion of the Board of Directors." and

WHEREAS, the members and Board of Directors of Hewlett's Run desires to modify ARTICLE VI, Section12; and

WHEREAS, to accomplish this purpose ARTICLE VI, Section 12, shall read, "At the time title is conveyed to a new owner, each new owner shall contribute to the association as a working capital the amount of two months of the current annual assessment. Amounts paid into the working capital fund are not to be considered as advance payment of regular assessments." and

WHEREAS, the signatures of two-thirds (2/3rd's) of each class of the members of the Association have been obtained in accordance with ARTICLE XIII, Section 5, as attested to by the Association President and Secretary;

NOW, THEREFORE, IT IS RESOLVED, that ARTICLE VI, Section 12, is hereby amended to read as follows: "At the time title is conveyed to a new owner, each new owner shall contribute to the association as a working capital the amount of two months of the current annual assessment. Amounts paid into the working capital fund are not to be considered as advance payment of regular assessments."


