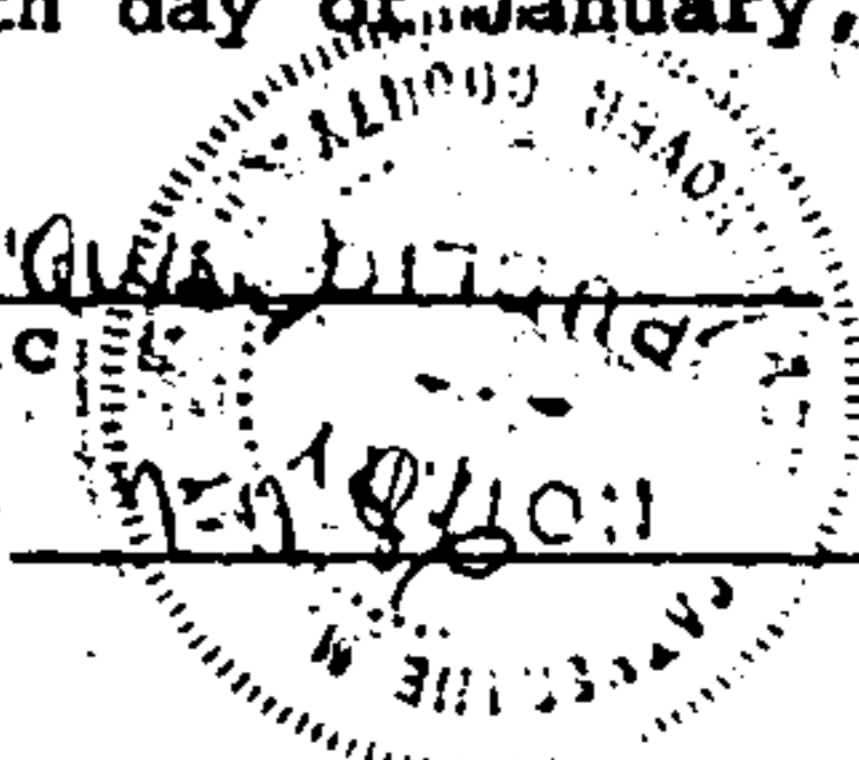

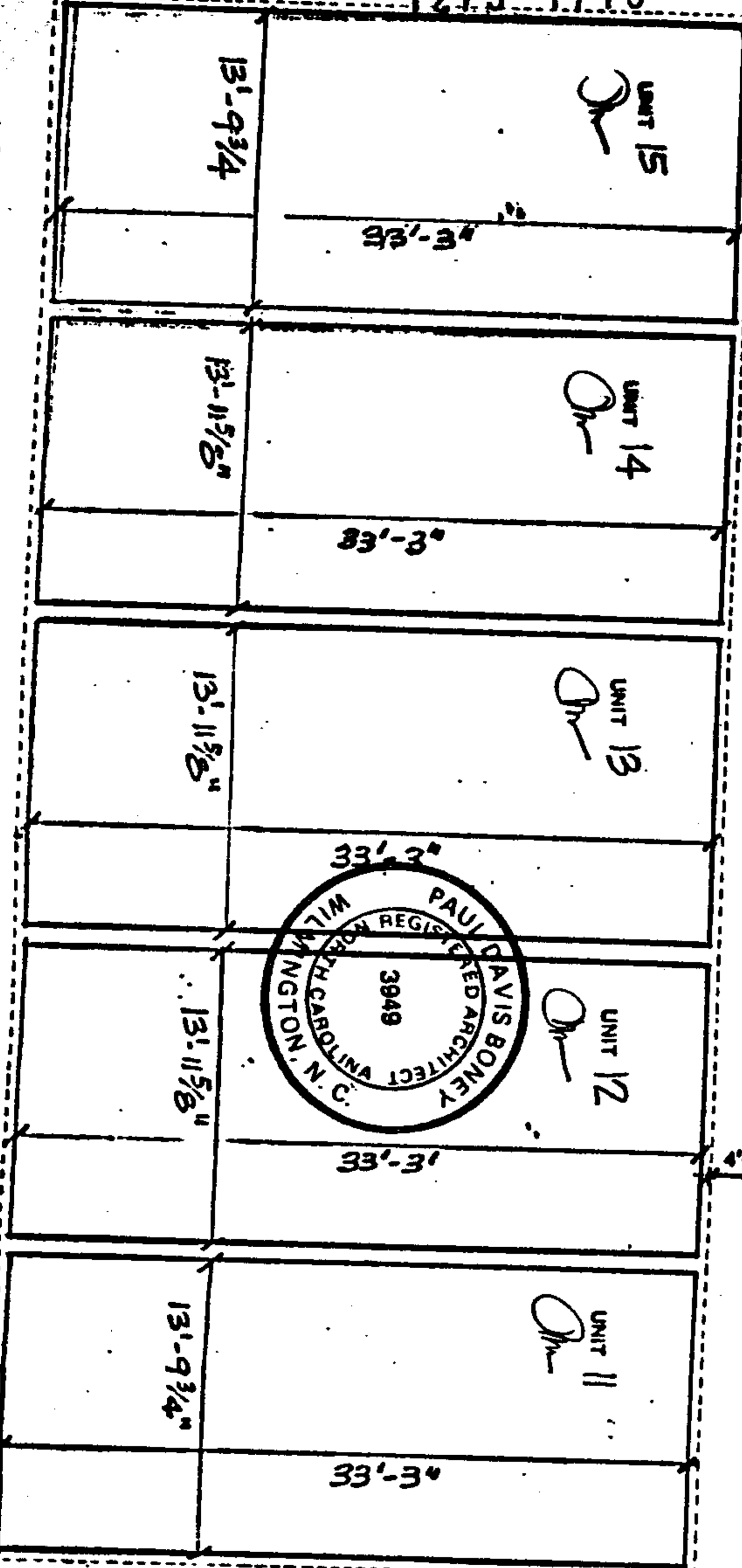
# THIRD FLOOR PLAN

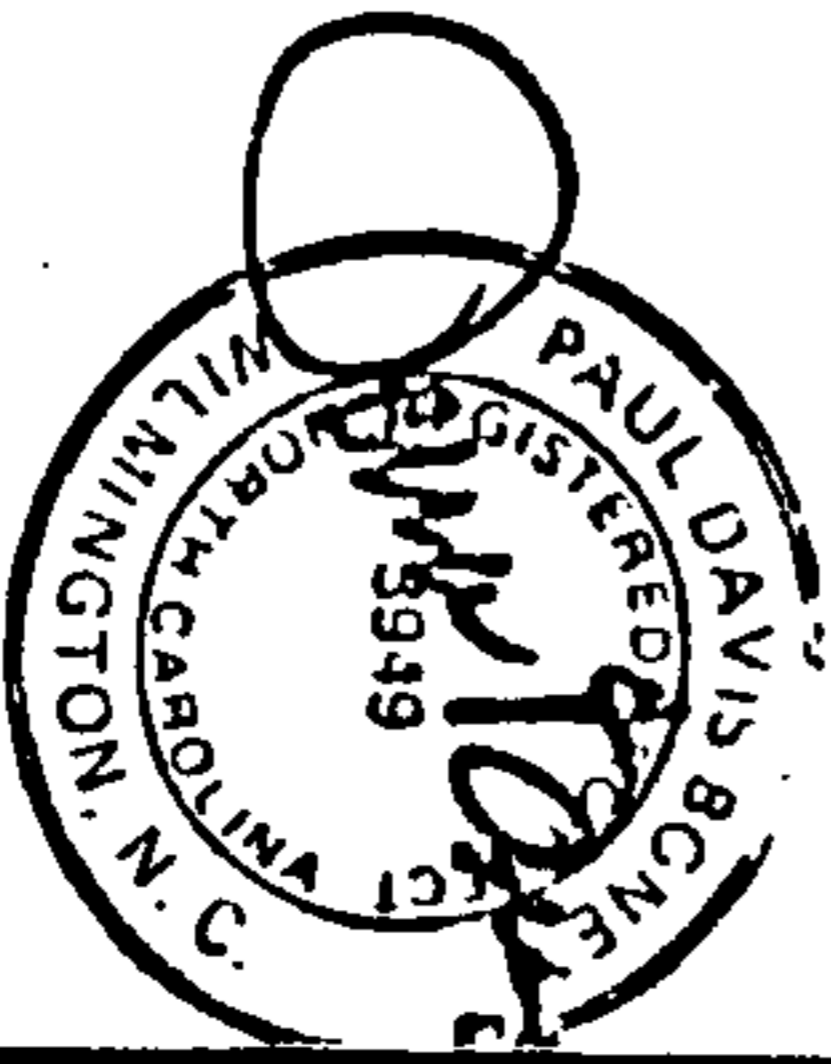
